  - (DoD REPI Program) The DoD REPI Program, in partnership with the U.S. Department of Agriculture and the Department of the Interior, has announced that the Sentinel Landscapes Federal Coordinating Committee will now accept applications for the Fiscal Year (FY) 2017 Sentinel Landscape designation process. Entities that are eligible to submit an application include Federal agencies; state and local governments; Native American tribes; for-profit and non-profit organizations or associations with conservation, agricultural, or silvicultural missions; municipal water treatment entities; and water irrigation districts. Applications must be submitted electronically, and are due by March 30, 2017.

In conjunction with the opening of the FY17 application window, the Sentinel Landscapes Partnership has released the 2016 Sentinel Landscapes Report on the accomplishments of the Partnership to-date.

(USFS) The U.S. Forest Service is developing new tools to identify strands of longleaf pine, using new software to train computers how to analyze and compare patterns in massive, high-resolution aerial imagery files. These new analytical capabilities will become more important as longleaf conservation efforts expand from large tracts of public land to pockets of longleaf pine on private lands. #### • Threatened, Endangered, and At-Risk Species

- (USFWS) The U.S. Fish and Wildlife Service finalized the Endangered Species Act Compensatory Mitigation Policy, the first comprehensive treatment of compensatory mitigation under the authority of the ESA to be issued by the USFWS. The policy clarifies existing guidance and covers all compensatory mitigation mechanisms recommended or supported by USFWS when implementing the ESA. - (TNC) The Nature Conservancy (TNC) was among 129 organizations that signed a letter to Congress seeking a comprehensive solution to the wildfire suppression funding issue by funding fire suppression at 70 percent of the ten-year average. #### • Coastal Resilience and Regional Adaptation

(USFWS) The U.S. Fish and Wildlife Service has released final digital maps for all of the John H. Chafee Coastal Barrier Resources System (CBRS) units in Puerto Rico, the U.S. Virgin Islands, and Louisiana. The maps cover 514,834 acres, or approximately 15 percent of the entire CBRS system, and are updated once every five years.
