#### **FEATURE**

SERPPAS/Sea Grant Collaborating Towards Coastal Resilience in the Southeast Meeting: On August 27, 2019, SERPPAS joined with the Georgia Sea Grant Law Program at the University of Georgia to host Collaborating Towards Coastal Resilience in the Southeast. The meeting focused on a series of in-depth briefings and discussions on approaches to building coastal resilience to mitigate sea level rise and natural disaster threats to coastal installations. The briefings included: funding options (REPI, National Fish and Wildlife Foundation, and Office of Economic Adjustment), mitigation efforts at Tyndall Air Force Base, Army Corps of Engineers coastal resilience efforts, and state program efforts as well as legal and engineering perspectives on the issue. The meeting culminated in a focused session during which participants broke into state (Alabama-Mississippi, Florida, Georgia, North Carolina, and South Carolina) working groups to come up with proposed near term projects to address coastal resilience. A full meeting summary will be distributed at a later date.

The ECRF was established to increase the resilience of coastal communities located within federally declared disaster areas impacted by hurricanes Florence and Michael, and wildfires in 2018. Eligible projects must be located within the outlined National Coastal Resilience Fund (NCRF) Coastal Areas and be within counties that received a federal disaster declaration as a result of hurricanes Florence and Michael, and the wildfires of 2018. The reserve provides habitat and serves as a wildlife corridor for many rare, threatened, and endangered species including bald eagle, Atlantic sturgeon, shortnose sturgeon, red-cockaded woodpecker, and American alligator. # • Threatened, Endangered, and At-Risk Species

- ► (NFWF The National Fish and Wildlife Foundation's Longleaf Stewardship Fund awarded \$6.3 million in grants to 24 conservation projects to restore, enhance and protect longleaf pine forests in the Southeast. Every state in the historic longleaf range will receive grant money that will support efforts to conserve more than 316,000 acres of longleaf pine habitat and recover populations of at-risk wildlife. - ► (NFLT) A red-cockaded woodpecker captured at Camp Blanding was shown to have migrated from the Osceola National Forest 27 miles away, evidence that a project to preserve land within the O2O wildlife corridor is working. The bird captured at Camp Blanding was the first time this endangered species had moved between one of the national forests and the military installation since they began banding and recording the birds over 25 years ago. - ▶ (USFWS) The USFWS is proposing to list two North Carolina species, the Carolina madtom and the Neuse River waterdog, as endangered species throughout each's range with a 4(d) rule. They are also proposing designation of critical habitat for both species and are releasing a draft economic analysis. - ► (FL Cabinet) Florida Governor DeSantis and the Florida Cabinet approved the acquisition of an additional 717 acres within the Wakulla Springs Protection Zone Florida Forever project. The acquisition represents a successful multi-agency public and nonprofit partnership between the Florida Department of Environmental Protection, U.S. Forest Service, Florida Forest Service and Conservation Florida Inc. to protect water quality within the Wakulla Springs Basin. The 717-acre property is an integral part of the protection zone that connects the 632,890-acre Apalachicola National Forest with the 6,000-acre Wakulla Springs State Park and its national natural landmark spring, featuring 300 acres of longleaf pine trees. - ► (FL Senate) On June 28, 2019, the Florida governor signed an amendment to Florida SB 620 Military Installation Protection. The amended version of the bill would allow for better cooperation between military bases and local government related to school districts, land development and easements by prohibiting construction of structures or other activities that are incompatible with the mission of a military installation when the land lies within an area identified as a clear zone or an accident potential zone or within Military Influence Planning Area 1 or 2.
